- How effective do you think agencies are at keeping adults at risk safe in Newcastle?


Is there anything else you would like to tell us about keeping adults at risk safe in

Spotlight on...Organisational abuse enquiries

Organisational abuse is a form of abuse covered by multi-agency safeguarding adults procedures. In 2018-19, 10% of all concerns raised related to organisational abuse. Organisational abuse is defined in the Care Act as:

"neglect and poor care practice within an institution or specific care setting such as a hospital or care home, for example, or in relation to care provided in one's own home. This may range from one off incidents to on-going ill-treatment"

Organisational abuse enquiries can often be complex— there are likely to be a number of people at risk, a number of professionals involved and wider strategic implications.

Last year, the NSAB agreed guidance to assist practitioners in managing organisational abuse concerns. The guidance aims to ensure that appropriate action is taken based on the seriousness of the allegation that has been made. The guidance includes a description of the continuum of harm that may happen as a result of organisational abuse and the expected response from key individuals/teams/agencies with respect to the level of harm.
